### A.T. Maintenance Work Trip- Saturday March 4

For this first Saturday work trip of 2023, we will focus on treadway rehab and small blowdown removal in the Nantahala National Forest. Specific locations of work will be based on number of volunteers and weather. All work locations will be less than 5 miles round trip from the trailhead. Participants will need to wear sturdy footwear, bring work gloves, lunch, snacks and plenty of water. **Week 2 is May 30 to June 2** and includes: Intro to Trail Maintenance, LNT Trainer and Making Public Contacts, Advanced Axe Techniques and Hanging, and Advanced Wilderness Stewardship.

### Help Needed Planning for Soak Ash Facility Repairs

The Soak Ash facility near Pittman Center is used as housing for our Ridgerunners and our SWEAT and Rocky Top crews when they are not in the field. The facility was closed last fall when black mold was discovered. The ATC and the Park Service are working to remediate this issue and are hoping to have the facility available for use again by early summer. To help prevent future mold issues, there are some repairs that are needed at the facility. The ATC and SMHC would like to plan a joint work day to address some of these repairs. Specific dates are not known at this time. We are targeting for a weekend in either March or April. We are looking for volunteers that would be interested in helping with any of the following tasks:

- A. Replace existing gutters and downspouts
- B. Replace and paint damaged fascia boards
- C. Dismantle current well pump housing and secure insulated housing for pipes
- D. Paint DRYLOK on exterior masonry walls.

### A. T. Work Trips From 1/21/2023 to 2/15/2023

**1/21 - Charlie McDonald, Debbie McDonald - Mulch Operations** - Inventoried bags of mulch, turned over mulch under the tent for drying out.

**1/21 - Randy Bullock, Sunaree Bullock, Cindy Mease, Steven Fitzgerald - Brown Fork Gap to Stecoah Gap** - Cleared water bars and inspected shelter and water source. Introduced new volunteers to trail maintenance.

**1/23 - Randy Bullock - AT Mgt, Mtgs & Admin** - Sat in on a meeting with several representatives from Forestry, ATC, DOT, and contractors relating to the corridor K project on NC 143 to discuss hiker safety and other aspects of the land bridge at Stecoah Gap.

**1/25 - Randy Bullock, Sunaree Bullock, Cindy Mease - High Pt E of Walker Gap to Yellow Creek Gap** - Moved 7-8 small trees/brush off the trail, took photos of Cable Gap shelter for reference. Looked at condition of privy. Packed out trash.

**1/27 - Randy Bullock, Sunaree Bullock, Cindy Mease - High Pt E of Walker Gap to Yellow Creek Gap** - Cleaned Privy at Cable Gap. Cut all reported blowdowns in this section.

**1/29 - Randy Bullock, Franklin LaFond - Cheoah Bald to Swim Bald** - Emptied privy and added mulch to aid in composting, filled leaf buckets. Cut 8 small blowdowns, packed out trash from privy and shelter.

**2/1 - Franklin LaFond, Randy Jenkins, Jim Rugh - Outreach & Education** - New Maintainer Administrative Orientation. Review JHA, Tailgate safety, and reporting work hours.

**2/8 - Keith Mertz - Yellow Creek Gap to Cody Gap** - Pulled 2 small blowdowns off trail. Tossed limbs off trail. Lopped intruding vegetation.

**2/8 - Pete Berntsen - Gap W of Masa Knob to Newfound Gap** - Removed small debris from entire section. Cut and removed 3 approximate 2-inch diameter blowdowns. Cleaned 4 water drains between Icewater Spring and The Boulevard and an additional 8 water drains to Sweat Heifer Boulevard. Tapped down three pieces of rebar near 1.5-mile NE of NFG.

**2/11 - Franklin LaFond - Fontana Dam to Stecoah Gap** - Walked from each of the road crossings to identify and flag work areas for upcoming March work day. Removed a couple small blowdowns and limb debris from trail. Talked with crew that is currently clearing trees at the Stecoah Gap crossing. Collected locust logs from roadside where NCDOT crews had cleared a blowdown. These logs were transported to the stash near Fontana Marina and split to usable sizes.

**2/11 - Lisa Sumter - Davenport Gap to Chestnut Br Trail** - Removed numerous branches from trail. Sawed & cleared a tree & a rhododendron which were across the trail. There is a large uprooted tree across the trail at 1.6-1.7 miles, not far from Chestnut Branch. Someone has cleared a path around the backside, I cut out a few more roots to make it a bit easier to get past. Checked the shelter area. There was a 2 ft tall aluminum pot with a lid in the shelter which had trash in it, packed out the trash, left the pot to retrieve later.
